RULES & REGULATIONS FOR IMMERI MEMBERSHIP

1. MEMBERSHIP

1.1. Pre-Associates, Elite Pre-Associates, Associates, Elite Associates, Executives, Elite Executives, Managers, Elite Managers, Directors, 1-Star Directors, 2-Star Directors, 3-Star Directors, Sapphire Ambassadors, Emerald Ambassadors and Diamond Ambassadors are all registered Independent Distributors of IMMERI (hereinafter referred to as "IMMERI").

1.2. No Independent distributor shall represent that he or she has any employment relationship with IMMERI or any of its subsidiary companies. Independent Distributors shall indemnify IMMERI against any suit arising from such representation.

1.3. No Independent distributor shall state or imply that he/she has any authority to bind or assume obligations for or on behalf of IMMERI.

2. MEMBERSHIP STATUS

2.1. Independent Distributors are NOT allowed to transfer or change Sponsor after the Membership has been activated.

2.2. Immeri Membership is valid for life.

3. INHERITANCE & TRANSFER

3.1. Your rights and interests to IMMERI's marketing plan are transferable only upon a result of old age, relocation, disability or death.

3.2. The beneficiary must be selected from one of the Independent Distributor's immediate family members and must be above 18 years of age. He/she must meet all the respective conditions and to show capabilities to perform your duties and responsibilities in order to participate in the IMMERI's business.

3.3. In the event of death of an Independent Distributor and should there be no beneficiary appointed after 6 months of the death of the Member, the Membership will be deemed non-transferable and unfit for inheritance.

4. TERMINATION

4.1. Immeri may take the necessary action as provided in these rules and regulations which may include warning, suspension, or termination of distributorship should any Independent Distributor be discovered to have violated Immeri's Rules or Regulations.

4.2. IMMERI shall have the right to take any action or make any claims against any distributor for compensation, damages, and legal costs.

5. RESPONSIBILITIES OF A MEMBER

5.1. Independent Distributors shall ensure best effort to obtain information concerning IMMERI products, promotions, and Rules & Regulations as released by IMMERI from time to time.

5.2. All products of IMMERI shall be sold to non-Independent Distributors at its Customer Price as decided by IMMERI. No Independent Distributor is allowed to raise or lower the Customer price of any products.

5.3. Independent Distributor shall not make any claims on the products other than those printed on the product labels or on official IMMERI literatures.

6. PROHIBITED ACTIVITIES

6.1. Independent Distributors shall NOT make any false or destructive claims about IMMERI or its products, which would unfavorably affect the interest or reputation of IMMERI or the sale of its products.

6.2. Independent Distributors shall not use fraud, coercion, or harassment in any unlawful means to promote IMMERI's products. Similarly, Independent Distributors should not omit any information about IMMERI and any relevant information about its products to any customers.

6.3. Independent Distributors shall not make use of any of IMMERI's intellectual properties without a formal consent in writing and approved by IMMERI.

7. BONUSES

7.1. Commissions, rewards, incentives, and benefits (hereinafter referred to as Bonuses) are all expressions used by IMMERI to describe the privileges which a qualified Independent Distributor will receive.

7.2. The total Bonus Points accumulated by Independent Distributors in various countries shall be consolidated and calculated in China Renminbi.

7.3. Bonus Points shall be calculated in China Renminbi where the Bonuses shall be converted to the participating countries' local currencies upon withdrawal. IMMERI reserves the right to fix an appropriate exchange rate for all bonuses withdrawal requests.

7.4. All Bonuses, which an Independent Distributor has accumulated from both local and foreign markets, will be distributed by IMMERI in the local currency for which they have signed up.

7.5. IMMERI reserves the right to recall any excess bonuses given out to Independent Distributors.

7.6. In countries where the law stipulates a valid citizenship or a work permit in required to receive their Bonuses, IMMERI will require all Independent Distributors to submit copies of their original citizenship or work permit for bonus entitlement.

7.7. IMMERI shall not be liable for any bonus payout if the requirements are not being met and IMMERI shall also not be responsible for any Independent Distributor's citizenship or work permit application or payment to relevant authorities.

8. TAXES

8.1. Independent Distributors may obtain their yearly income statement from IMMERI upon request.

8.2. Independent Distributors are solely responsible to pay their income taxes or any related taxes in compliance with tax regulations of the respective country which they operate aside from being an Independent Distributor.

8.3. Independent Distributors must obtain a local tax number and relevant permits for the processing of their bonus entitlement in countries where the law stipulates this as a regulated practice for any business activities if they intend to conduct international sponsoring activities.

8.4. To comply with the laws of the relevant tax authorities, IMMERI reserves the right to request for a passport copy, local tax reference number, or any other identification certificates/documents for withholding tax purposes for the purpose of paying foreign Bonuses to Independent Distributor.

8.5. Pursuant to any applicable Federal, State, and Local laws and/or regulations, IMMERI is compelled to withhold taxes and/or any form of applicable taxes from any compensation and/or bonuses payable to distributors under this Rules and Regulations.

9. OTHERS

9.1. IMMERI reserves the right to make changes to the product prices and Bonus Points in any country at any time.

9.2. Independent Distributors understand that the Rules and Regulations for your Membership may be amended and updated by IMMERI at its sole discretion, without prior notice, as necessary.

10. PRIVACY POLICY

10.1. IMMERI will process your data in accordance with your rights under the Data Protection Act specific to the country from which you signed up at.

10.2. PERSONAL DATA

10.2.1. IMMERI will process your personal data as listed, but not limited to the following items, which has been provided by you to IMMERI for the furtherance of your direct selling transactions:

- Name, identity card number, sex, date of birth, race, religion, nationality, etc.

- Spouse's name, identity card number and beneficiary's name, identity card number etc.
- Contact information, address, phone number, email address, etc.
- Bank account number and details.
- Photographs given to IMMERI and/or taken at official company's functions, etc.
- Testimonial and etc. given to IMMERI

10.3. USAGE OF DATA

10.3.1. IMMERI will use and/or process the personal data for, among others, the following reasons:

- Inform you of sales promotions and products updates Name, identity card number, sex, date of birth, race, religion, nationality, etc.
- Disclose your contact information to your sponsor upon their request to inform you the latest sales promotion, products update, company's events and etc. Spouse's name, identity card number and beneficiary's name, identity card number etc.

10.4. DISCLOSURE OF YOUR PERSONAL DATA

10.4.1 All personal data acquired by the Company shall only be for the purposes of this Agreement and shall not be further processed or disclosed without your consent or otherwise required by law.

10.5. SECURITY

10.5.1 IMMERI shall keep and process your personal data in a secure manner, where practicable, in accordance with the applicable laws and regulations to prevent the unauthorized or unlawful processing of your personal data including loss, misuse, modification, unauthorized or accidental access or disclosure, alteration or destruction.

10.6. DECLARATION
